#### **Preparatory Instruction**

## 1. † Fluocinolone Acetonide 1% Stock Solution preparation:

A. Levigate the Fluocinolone Acetonide (Anhydrous) (Micronized) (0.100 g) with the Alcohol (95%) (0.5 mL).

End result: Homogeneous liquid-like dispersion.

B. Add additional Alcohol (95%) to the mixture (Step 1A) to fill to the required amount (10.0 mL).

Specifications: Continuously mix until all solid particles have completely dissolved.

End result: Homogeneous liquid-like solution.

- A. In the given order, sequentially add the following ingredients to the U-Mild™ Shampoo Base:
  - -Fluocinolone Acetonide 1% Stock Solution (1.00 mL plus processing error adjustments)
  - -Salicylic Acid (Hydrosoluble, 50%)

Specifications: Continuously mix until all solid particles have completely dissolved.

End result: Homogeneous liquid-like solution.

Note: Add the next ingredient, once the previous one has been completely added and dissolved.

## 3. **Filling to volume:**

A. Add Purified Water to the mixture (Step 2A) to fill to the required batch size (100.0 mL *plus* processing error adjustments).

Specifications: Continuously mix until homogeneous.

End result: Homogeneous liquid-like solution.

### 4. **Product transfer:**

Transfer the final product into the specified dispensing container (see "Packaging requirements").
