



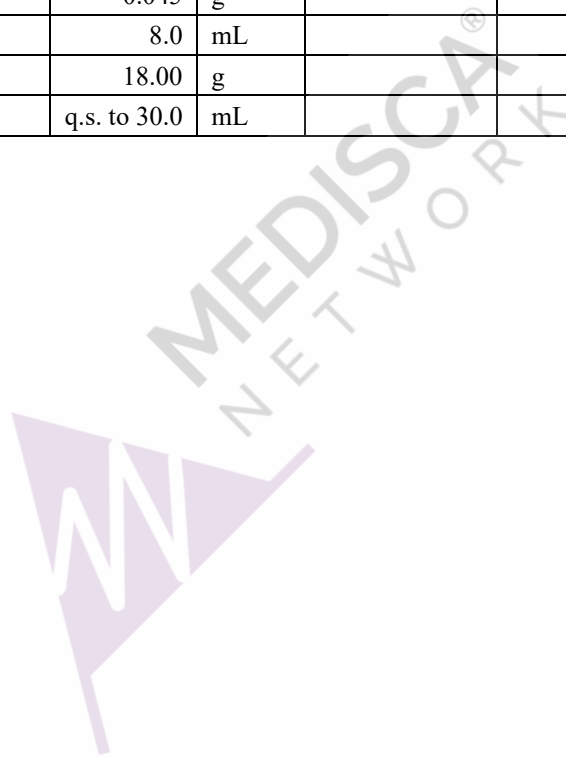

Processing Error / Testing Considerations: To account for processing error considerations during preparation, it is suggested to measure an additional **12 to 15%** of the required quantities of ingredients.

Preparatory Instruction

1.	<p><u>Preparatory Step:</u></p> <p>A. Preheat an appropriate convection oven.</p> <p><u>Specifications:</u> Temperature: 50°C.</p>
2.	<p><u>Powder-liquid preparation:</u></p> <p>A. By geometric addition, combine and triturate the following ingredients together to form a fine, homogeneous powder blend:</p> <ul style="list-style-type: none">-Progesterone (Micronized)-Bitterness Reducing Agent (NF-01) (Natural) (Powder)-Menthol (Crystals) (Levorotatory) (Natural)-Sucralose <p>B. Levigate the fine, homogeneous powder blend (Step 2A) with the Purified Water (8.0 mL <i>plus</i> processing error adjustments).</p> <p><u>End result:</u> Homogeneous liquid-like dispersion.</p>

3.	<p><u>Medium incorporation:</u></p> <p>A. Incrementally add the homogeneous liquid-like dispersion (Step 2B) to the NovaFilm™ Gel Base.</p> <p><u>Specifications:</u> Continuously mix, using high-shear mixing techniques.</p> <p><u>NOTE:</u> Ensure mixing process does not incorporate any air.</p> <p><u>End result:</u> Homogeneous gel-like dispersion.</p>		
4.	<p><u>Filling to volume:</u></p> <p>A. Add additional Purified Water to the mixture (Step 3A) to fill to the required batch size (30.0 mL <i>plus</i> processing error adjustments).</p> <p><u>Specifications:</u> Continuously mix, using high-shear mixing techniques.</p> <p><u>NOTE:</u> Ensure mixing process does not incorporate any air.</p> <p><u>End result:</u> Homogeneous gel-like dispersion.</p>		
5.	<p><u>Mold filling and heating:</u></p> <p>A. Fill the 30 blister mold cavities with 1.00 mL of the homogeneous gel-like dispersion (Step 4A) per cavity. Spread the homogeneous gel-like dispersion in the cavity to a uniform thickness.</p> <p><u>NOTE:</u> Ensure no air bubbles are added to the mold cavities.</p> <p>B. Heat the filled blister molds to 50°C for 60 to 90 minutes in the preheated convection oven. Do not overheat.</p> <p><u>Specifications:</u> Homogeneous solid dispersion.</p>		
6.	<p><u>Cooling:</u></p> <p>A. Carefully remove the blister mold from the heated oven.</p> <p>B. Allow the films to cool for an additional 15- 30 minutes in the blister molds at controlled temperature and relative humidity.</p>		
7.	<p><u>Validation technique:</u></p> <p>A. Weigh 6 films separately.</p> <p>B. The final weight of each film from Step 7A (not including the weight of the blister mold) shall not be less than 90% and not more than 110% of the theoretically calculated weight 0.159 g in accordance to USP guidelines.</p>
